#### AGENDA ITEM 5: HOMELESS STUDY AND WATER QUALITY PRESENTATION

David Pohl and Steve Gruber presented the "SDR WMA Service Array Analysis, Addressing Water Quality Impacts of the Homeless".

- This study is being developed to determine what services are available to the homeless
  population in the SDR watershed, what services are needed, and whether there may be
  a connection between the homeless population and water quality. The spatial match or
  mismatch between encampments and services will be investigated, and the data may
  provide a basis for developing targeted and informed policies and services.
- The Participating Agencies (PAs) in the WMA may be asked to collaborate on a pilot evaluation by providing data (e.g., bacteria, trash, source identification studies, GIS data, encampment survey data) and contact information (e.g., public health, social services department contacts).
- Steps forward may include workplan development, gathering of data, and funding support.
- The group had a Q&A and discussion. David and Steve will determine what data are already available to them and then provide a list of asks from the PAs.
- Ruth (County of San Diego) will email the presentation to the group.

## AGENDA ITEM 6: WORKGROUP BUDGET

Ruth presented slides and noted budget changes.

- Water quality monitoring budget was updated to include new 303d constituents.
- Bacteria TMDL lab analysis budget was updated to include sharing costs (previously costs were covered by the County).
- Forester Creek Bacteria TMDL follow ups were added
  - A workplan overview was provided by Michelle (Weston Solutions)
  - Ruth emailed workplan to the group. Comments are to be provided by Dec 7 in order to finalize the workplan. The vote will be by email or at the next meeting.
- Ruth will send the revised budget to the group.

## AGENDA ITEM 7: WATER QUALITY MONITORING UPDATE

Joanna (County of San Diego) provided the following update:

- The October Bacteria TMDL progress report was reviewed.
  - Bacteria TMDL dry weather monitoring was conducted on October 22, 2018.
     Results for all three indicator bacteria were above the geometric mean receiving water limitation at SDR-FC1, SDR-FC-2 and SDR-MLS. Fecal coliform was above the geometric mean receiving water limitation at SDR-CDE. There were no exceedances at the beach site FM-010.
  - Bacteria TMDL wet weather monitoring was conducted on October 13, 2018.
     Results were compared to the single sample maximum receiving water limitations. All three indicator bacteria were above the objectives at all four creek sites. There were no exceedances at the beach site FM-010.
- The group discussed the Bight additional sediment analysis request. Most PAs in the group are not in favor of participating. Participation is not required if group does not agree.

## AGENDA ITEM 8: WATER QUALITY IMPROVEMENT PLAN 2017-18 ANNUAL REPORT

Sheri (Weston Solutions) led a discussion of the draft report status

- The PAs were thanked for the comments provided on the first draft.
- Currently, some of the progress to goals, IC/ID, City of San Diego, and Famosa Slough information is outstanding.
- Ruth suggested introducing fact that the PAs received irrigation audits and are
  responding to them. Other watersheds are planning to include this information at the
  beginning of strategy section. Sheri suggested a watershed-level paragraph in Section 5
  (adaptive management, since this could be considered a request from the San Diego
  Water Board) that then references the jurisdictional responses in Appendix 2.
- Ruth noted that the County strategies section included a lot of highlights, and asked if the group wanted to discuss. The County will not be scaling back their section, but other jurisdictions may provide additional highlights.
- Sheri noted that Weston is pulling a couple of items from the strategy sections (4.2) for the executive summary. If anyone has preferred discussion items, let Weston know.
